Profile

Floris Vermeulen is Associate Professor and former Chair of the Department of Political Science (2015-2017) and former Interim Head of the Sociology Department (2015) both at the University of Amsterdam. He has been Co-director of the Institute for Migration and Ethnic Studies (IMES) (2011-2015) and a Member of the board of directors IMISCOE European research network on IMISCOE International Migration, Integration, and Social Cohesion (2011-2015). In that period he was also the head of the research programme group ‘Challenges to Democratic Representation’ of the Amsterdam Institute for Social Science Research (AISSR), University of Amsterdam.

Vermeulen has been participating as research leader in several large-scale, collaborative FP6 and FP7 European research projects, among which Eurospheres, RELIGARE and INTEGRIM, as well as senior researcher in the ELITES project. In the last three years he conducted two projects for the Dutch *Sociaal and Cultureel Planbureau* (one on social-cultural integration of refugees in the Netherlands and one currently on the political behaviour of Dutch people with a migrant background in the Netherlands together with prof. Jaco Dagevos). Currently he also works on a research project on linking social capital of young people in deprived areas in Amsterdam for the Amsterdams Kenniscentrum voor Ongelijkheid (together with Femke Kaulingfreks) and for the city of Amsterdam on the low turnout during the recent local elections 2022 (together with Femke Kaulingfreks). He (co-)supervised multiple successful PhD-thesis and is also regularly asked by Dutch ministries and municipalities to participate in advisory committees on issues of diversity, integration and radicalization.

Vermeulen’s research focuses on the civic and political participation of immigrants at the local level and local integration and preventive radicalisation policies and their effects. His work has been published in different international volumes and prestigious academic journals such as *Political Psychology*, *European Union Politics*, *Journal of Ethnic and Migration Studies*, *Ethnic and Racial Studies*, *Nonprofit and Voluntary Sector Quarterly*, *Urban Studies*, *West European Politics*, *Electoral Studies*, *British Journal of Sociology*, *Political Psychology*, and *Terrorism and Political Violence*. He has been a member of the Editorial Board of *Urban Affairs Review* (2017-2021).
